RESOLUTION NO. 3-11

A RESOLUTION OF SOUTH BUFFALO TOWNSHIP, ARMSTRONG COUNTY PENNSYLVANIA TO SUPPORT THE SPECIAL OCCASION LIQUOR PERMIT OF THE CADOGAN FIELD AND STREAM ASSOCIATION

WHEREAS, South Buffalo Township, Armstrong County, Pennsylvania is a dry municipality; and

WHEREAS, the Cadogan Field and Stream Association will be holding several fund raising projects within the confines of South Buffalo Township; and

WHEREAS, the Cadogan Field and Stream Association will be holding a Turkey Shoot on April 23 2011; a Trout Derby on May 21, 2011; a Pig Roast on July 16, 2011; a Horseshoe Contest on August 13, 2011; a Gun Raffle on September 17, 2011; a Turkey Shoot on September 12, 2010 and a Turkey Shoot on October 9, 2011 on club grounds; and

WHEREAS, the Cadogan Field and Stream Association requested that the South Buffalo Township Board of Supervisors approve of the association's request for a Special Occasion Permit; and

WHEREAS, the applicable provisions of the Pennsylvania Liquor Code allow for the issuance of a Special Occasion Permit in a dry municipality provided the governing body confirms support for the issuance of such a permit.

NOW THEREFORE, IT IS RESOLVED BY THE SOUTH BUFFALO TOWNSHIP SUPERVISORS as follows:

The South Buffalo Township Board of Supervisors, after careful consideration of the request by the Cadogan Field and Stream Association, do hereby support the application to the Pennsylvania Liquor Control Board by the Cadogan Field and Stream Association for a Special Occasion Permit to allow alcoholic beverages to be served at a Turkey Shoot on April 23 2011; a Trout Derby on May 21, 2011; a Pig Roast on July 16, 2011; a Horseshoe Contest on August 13, 2011; a Gun Raffle on September 17, 2011; a Turkey Shoot on September

12, 2010 and a Turkey Shoot on October 9, 2011 at the club's grounds located in South Buffalo Township, Armstrong County, Pennsylvania.


